Dear Parents and Carers,

Tomorrow marks the start of written exams for year 11. Many of our students have sat their MFL orals and art exams and their attitude towards preparation for these has been excellent.

Exam seating plans

Please ensure your child checks the Bromcom app for exam seating plans. Seating plans will also be made available in the main corridor of the school.

Uniform and equipment

Students must attend exams in uniform. Equipment for exams must be in a clear pencil case, with a clear water bottle. The water bottle must not have a logo.

Punctuality

Students must be punctual to exams. Late entries to exam environments may disrupt the exam experience for others. Students must attend exam spaces 10 minutes prior to the exam start time. All students are expected to attend the exam briefings to ensure punctuality.

Student illness must be reported to the school before the start of exams.

Arrangements for Maths, English and Science

Students must spend the remainder of lesson 2 in the hall, should the exam finish before 11.10.

For English literature on the 20 May, students will finish the exam during break and so will have an extended break until 12.00. After which they will return to lessons, or to exam briefings for afternoon exams. This is a one-off and does not apply to any other exams.
